## **ELIGIBILITY:**

To be eligible to serve on most Committees or Boards you must qualify as a municipal elector, specifically:

You must be 18 years of age and older;

You must reside in the municipality, or be an owner, tenant of land (or spouse of same);

You must not be prohibited from voting;

You must be a Canadian citizen

To be eligible to serve on the Larder Lake Advisory Planning Committee

Note: Qualifications under the Corporations Act require that directors be:

Must be 18 years of age or older; unless individual is applying for youth director position. .

Not be an undischarged bankrupt.

To be eligible to serve on the Larder Lake Public Library Board:

Must be a Canadian Citizen, and at least 18 years old; unless individual is applying for youth director position.

Must be a resident of the Township of Larder Lake; and

May not be employed by the Library Board, or by the municipality or township.
